Patrick D. Quinlan died at the Grand Hotel, Wednesday night week. His disease was pneumonia, contracted a week ago in coming up to this city from Petaluma. A native of Queen's Co., Ire. aged 73y; he came to Ca. from Palmyra, N.Y., the 1st of May 1865 at the time of the Panama riot, and himself, his wife and 2 children lost all of their personal effects on the Isthmus; came to Sonoma County in 1867, settled at Bodega, on a farm purchased from the late Capt. Smith. He leaves a wife and 5 sons and 1 daughter now a resident of Tulare Co., who is married to John Manning. He will be buried in the family plot at Bodega. (Santa Rosa Democrat)



A PECULIAR CASE.

The Jury Decides That Patrick Quinian was of Sound Mind.

There was concluded here last Friday afternoon the trial of a very peculiar case. Patrick D. Quinlan died in this city in November, 1892, and the day before his death he made a deed to his son Daniel of 150 acres of his ranch near Bodega Bay, and a deed to his wife. Mary A. Quinlan, of the rest of the home place, consisting of about 400 acres, and his cattle and other personal property valued at about \$2,500. The land is worth about \$60 per acre. He left surviving him one daughter, Mrs. Mauning, and five sons, Martin, Joseph, James, Thomas and Daniel. Thomas lives in Ireland, the danghter in Tulare county, Martin in San Francisco and the other boys in this county. Martin Quinlan is a lawyer and some years ago practiced law in this city as the partner of James T. Noon. He then removed to San Francisco where he has resided ever since. The deeds to wife and son were drawn by A. D. Laughlin and the execution of them was witnessed by him and William Longmore, the assessor. Both Daniel and the widow had their deeds recorded and went over to Bodega after the funeral of the father and husband. The widow then leased the ranch and personal property conveyed to her, and according to the testimony of several persons, while there told that Patrick D. Quinlan was sane and in his right mind to the last. About March she went to live with Martin in San Francisco, where she has continued to reside ever since.

A few days after the death of Patrick D. Quinlan a suit was commenced by Martin, Joseph, and Mrs. Manning against Daniel, the widow, Thomas and James to set aside the deed to Daniel upon the ground that Patrick D. Quinlan was of unsound mind and that he was so weak from illness as to be not mentally competent to make the deed.

It appears that Mrs. Quinlan signed the deed to Daniel with her husband. Mrs. Quinlan and, in fact, all the defendants but Daniel, made default. Daniel answered denying the mental incompetency of the father. George Pierce and J. T. Campbell represented the plaintiffs and James W. Oates the defendant, Daniel Quinlan.

Upon the trial the widow was called as a witness by her son Martin, and testified that her husband was dying when he made the deed to Daniel and that he did not know what he was doing. She admitted that the deed to her was made at the same time, under the same circumstances, and that she had had it recorded and that she afterwards leased the property conveyed to her. She did not know that she had been made a party defendant to the action and had no recollection of any papers in the case having been served upon her, though there was an affidavit of service, from a man in San Francisco. on file.

The breaking of the deed to Daniel would have been the same as the breaking of the deed to the widow, as they both rested upon the same facts and were made at the same time. The widow did not seem to realize this.

There was much evidence showing prior declarations by Patrick D. Quinlan as to what he would do with his property, some swearing that he had said to them that he was going to leave it to all his children alike, and others that he had said he was going to leave the piece he conveyed to Daniel to him, and one of them testified that he had said to him that Martin had had his share, and that he would give Daniel the 150-acre tract and the balance to his wife, as she could look out for James, who was then in the insane asylum, and Joseph, who was wasteful, and for Mrs. Manning, and that Thomas had gotten as much as his share in Ireland. To one of the witnesses when about to make the deed he said that he wanted to do so before Martin came.

The case was hotly and vigorously contested, resulting in a verdict Friday afternoon that the grantor was of sound mind and fully understood what he was doing when he made the deed to Daniel.

The upholding of the deed to Daniel upholds that of the widow as well.

A goodly number of people from about Bodega Corners was in attendance.


